The 1<sup>st</sup> appellate authority and Executive Director, RMSA, Shri Dhrubajyoti Das has submitted one written statement vide letter no. RMSA/Estt./RTI/103/2011/Pt./Vol.3/314 dated 21.10.2021 whereby it is submitted that the sought for informations has already been furnished and the appellant had received it by hand on 22.10.2021.

Perused the case record. The appellant Sri Arif Jwadder submitted one petition dated 05.10.2020 under the RTI Act, 2005 before the APIO, o/o the Mission Director, RMSA seeking certain informations.
