## O R D E R 28.10.2021

The appellant Sri Abul Hussain Laskar informs the Commission through his e-mail dated 28.10.2021 that he is unable to attend today's hearing for his brother's death. The SPIO, o/o the Chief Executive Officer, Zilla Parishad, Hailakandi is absent without any intimation.

The 1<sup>st</sup> appellate authority of Hailkandi Zilla Parishad has not submitted any written statement in respect of action taken against 1<sup>st</sup> appeal petition dated 27.01.2021.

Perused the case record. The appellant submitted one petition dated 18.11.2020 under the RTI Act, 2005 before the SPIO, o/o the CEO, Zilla Parishad, Hailakandi seeking certain informations. He did not receive the desired informations within the stipulated period of time and submitted 1<sup>st</sup> appeal dated 27.01.2021 before the FAA, o/o the Zilla Parishad, Hailakandi. No action was initiated after submitting of 1<sup>st</sup> appeal petition also. Therefore, he submitted 2<sup>nd</sup> appeal dated 03.04.2021 before the Commission.

From a plain reading of the application dated 18.11.2020, it is observed that informations sought for are part of the record to be maintained by the office of the Zilla Parishad, Hailakandi. Why no action is taken to furnish the sought for informations by the SPIO is better known to him. Inaction of FAA is also regrettable. Therefore, **the Commission directs the SPIO**, o/o the Zilla Parishad, Hailakandi to furnish the sought for informations within two weeks' time from the date of receipt of this order.

With the above directions, the  $2^{nd}$  appeal dated 03.04.2021 is hereby disposed of.
