ORDER 28.09.2021

The appellant/complainant Smti. Rita Hazarika is present.

Sri Bolin Handique, SPIO & Asstt. Engineer, Bokakhat Municipal Board is present.

Seen the order of the Commission dated 02.03.2021. The appellant submitted one application under the RTI Act, 2005 dated 15.02.2021 stating her grievance for not receiving the proper informations from the SPIO of Bokakhat Municipal Board. The said application of Smti. Rita Hazarika dated 15.02.2021 was given to the SPIO of Bokakhat Municipal Board with a direction to submit pointwise reply in an affidavit. Accordingly, the SPIO of Bokakhat Municipal Board submitted pointwise reply on the application of the appellant dated 15.02.2021 through an affidavit dated 17.04.2021. A photocopy of the affidavit dated 17.04.2021 submitted by the SPIO, Bokakhat Municipal Board be furnished to the appellant. After receipt of the copy of the affidavit and informations thereon, if not satisfied, she will submit in writing to the SPIO of Bokakhat Municipal Board for further clarification and informations. The SPIO, if he receives such application from Smti. Hazarika will arrange inspection of records as sought for by the appellant vide her RTI application dated 08.01.2020 in a mutually agreed working date. He will issue a letter to the appellant inviting her for inspection of records and to take copies of the same if so desired. The SPIO will facilitate the appellant for inspection of records relating to her RTI application dated 08.01.2020 and give copies of the selected informations desired by the appellant, free of cost upto 50 copies.

With the above directions, the 2<sup>nd</sup> appeal/complaint is disposed of.
