<u>O R D E R</u> 28.09.2021

The appellant Shri Premananda Medhi is present.

The SPIO & Circle Officer, Dispur Rev. Circle through his e-mail dated 28.09.2021 informs the Commission that he is unable to attend today's hearing due to some unavoidable circumstances and request to fix another date of hearing.

It is observed that the SPIO & Circle Officer, Dispur Rev. Circle is unable to attend hearing in consecutive two days and as such, today's hearing is taken *ex parte*.

Perused the case record. The appellant Sri Premananda Medhi submitted one petition under the RTI Act, 2005 dated 03.03.2020 before the SPIO of Dispur Rev. Circle seeking certain informations. He did not receive the sought for informations from the public authority and as such, submitted 1st appeal petition dated 21.08.2020 before the 1st appellate authority of Dispur Rev. Circle.

From the 2^{nd} appeal petition dated 01.12.2020, it is seen that he did not get any response either from the SPIO or the FAA of Dispur Rev. Circle and as such, he preferred 2^{nd} appeal before the Commission.

Seen the application dated 03.03.2020. The sought for informations should be part of record amounting to informations if any action has been taken by the office of the Circle Officer, Dispur Rev. Circle in respect of letter of Addl. Dist. Magistrate, Kamrup (M) issued by letter no. KMJ.11/2019/Pt/32/3099 dated 22.10.2019. Therefore, the Commission directs the SPIO of Dispur Rev. Circle to furnish the desired informations to the appellant Sri Premannada Medhi whatsoever is available within 30 (thirty) days from the date of receipt of this order.

With the above directions, the 2^{nd} appeal dated 01.12.2020 is disposed of.
