ORDER 27.10.2021

The appellant Md. Saibar Ali is present.

Sri Sujit Thakuria, SPIO of Pub Mangaldoi Dev. Block is present. He is assisted by Shri Hussain Ali, Secretary, Dhula Gaon Panchayat.

Perused the case record. The appellant submitted one petition dated 10.09.2020 under the RTI Act, 2005 before the SPIO of Pub Mangaldoi Dev. Block seeking certain informations. He did not receive the desired informations within the stipulated period of time and submitted 1st appeal dated 15.10.2020 before the 1st appellate authority of Pub Mangaldoi Dev. Block. Still he did not receive the desired informations for which he submitted 2nd appeal petition dated 15.12.2020 before the Commission. The informations sought for are very much part of the record to be maintained by the BDO and GP office. The SPIO of Pub Mangaldoi Dev. Block submits orally that most of the informations has been collected from the GP office and rest will also be collected soon. It is therefore ordered that either the SPIO of Pub Mangaldoi Dev. Block or GP Secretary of Dhula GP will furnish the sought for informations to the appellant within seven days of receipt of this order, free of cost.
