ORDER 27.09.2021

The appellant Sri Bikash Bucha is present.

Sri Tapash Gupta, Under Secretary to the Government of Assam and SPIO, Political (A) Deptt. is present and submits a written statement vide letter no. PLA(V)77/2021/43 dated 24.09.2021. It is submitted that Political (Vigilance Cell) Department, Government of Assam has issued a letter to the Superintendent of Police, Vigilance & Anti-Corruption, Assam according approval to register a criminal case against Sri Anamul Haque, the then Chief Engineer, Irrigation Department (now retired) vide letter no. PLA(V)/146/2010/148 dated 01.11.2019 copy of which is forwarded for the second time along with the letter dated 25.06.2021. It is also submitted that investigation is going on and as such, informations sought can't be furnished at present as per Section 8(1)(h) of RTI Act, 2005 since it may impede the process of investigation or apprehension or prosecution of offenders. Although it is submitted that investigation is going on, the SPIO fails to submit any document establishing registration of criminal case against the suspected officers. The Commission therefore, directs the SPIO of Political (A) Department, Government of Assam to submit written statement with documents that a criminal case has been registered and investigation is going on within 15 days of receipt of this order.

Fix next date of hearing on 22.10.2021 at 11:30 AM. This order shall constitute notice for hearing.
