The appellant Sri Ikbal Hussain Laskar has submitted one letter dated 11.04.2021 which has been received by the Commission on 23.04.2021.

The Addl. Deputy Commissioner & Nodal Officer, Aadhaar, Hailakandi has submitted one letter bearing no. HAA.20/2017/Pt./351 dated 20.04.2021 whereby it is informed that on receipt of 1<sup>st</sup> appeal petition dated 08.08.2020 from the Government of Assam in General Administration Department vide its letter no. GAG(A)118/2020/27 dated 27.08.2020, pointwise reply was furnished to the petitioner against point numbers 3, 5 and 6 of his petition dated 06.06.2020.
