ORDER 9.12.2021

- 1. The petitioner Sri Joydeb Das is present. The public authority i.e. the SPIO of the Food, Civil & Consumer Supply Sri Sanatan Haloi, Under Secretary and Sri Arup Bezbaruah, Superintendent of Department are present.
- 2. On perusal of the case records, it is seen that the petitioner has filed RTI petition dated 12.08.2021 before the SPIO of the Food Civil Supplies & Consumer Affairs Department seeking following information
 - (i) Whether Shri Dilip Deka as supply Inspector posting in BIEO as Superintendent by the Home/ FCS & CA Department. If yes, please furnish the following details:
 - (a) Whether FCS & CA Department has required a panel list of officers sent to Home Department for posing of Shri Dilip Deka Supply Inspector in BIEO as Superintendent during the period 2019 till date. If yes, please furnish following details:
 - (b) Please furnish procedure followed posting of Shri Dilip Deka as Superintendent in BIEO, along with a copy of penal list of officers which sent to the Home Department for posting of Shri Dilip Deka in BIEO.
 - (c) If, any minutes was made for prepare of penal list which sent to the Home Department, if yes, please furnish a copy of the same
 - (d) If, no any penal list prepared and not sent to Home Department, please furnish procedure followed for posting Shri Dilip Deka in BIEO and name of the officers and when he shall be withdrawn from BIEO.
- 3. In the mean time the SPIO & Under Secretary, Food, Civil, Supplies and Consumers Affairs Department has furnished the information vide letter No. FSB.94/2020/21 dated 26th August, 2021. However, the petitioner filed first appeal petition dated 24.09.2021 before the First Appellate Authority of Foods, Civil Supplies and Consumer Affairs Department stating that the copy of approval of the Hon'ble Minister, Food, Civil & Consumer Affairs Deptt is not furnished to him. Reportedly by not getting any information, the petitioner filed second appeal petition dated 01.04.2021 before the Commission. Accordingly the date of hearing is fixed today.
- 4. The SPIO of FCS &CA has submitted a written statement dated 8.12.2021 which is taken into case records, wherein they have enclosed the approval of Hon'ble Minister.

- 5. The petitioner raised the issue that he sought the approval of Hon'ble Minister for posting of Sri Dilip Kr. Deka as Superintendent of FS & CA not as Inspector of FCS & CA in BIEO. But the SPIO has furnished the approval Hon'ble Minister for posting of Sri Dilip Kr. Deka as Inspector.
- 6. In light of it, the Commission directs the SPIO to furnish a copy of the approval to the petitioner.
