**O R D E R**  
24.09.2021

The appellant Sri Bhaskar Mahanta is present.

The Circle Officer, Naharkatia Rev. Circle through his e-mail dated 23.09.2021 bearing no. NRC3/2013-14/5178 informs the Commission that the notice of hearing of the Commission dated 04.09.2021 is received by him yesterday only. Further, he is busy with duties of Covid-19 and PM Kishan verification work etc. and as such unable to attend today's hearing.

Perused the case record. The appellant submitted one application under RTI Act, 2005 dated 24.06.2020 before the SPIO of Naharkatia Rev. Circle seeking certain informations. The SPIO furnished informations on 30.07.2020. The appellant was not satisfied on the informations so provided and therefore submitted 1<sup>st</sup> appeal petition dated 03.09.2020 before the 1<sup>st</sup> appellate authority of Naharkatia Rev. Circle. The informations furnished on 19.10.2020 was also not satisfactory to the appellant and as such, he preferred 2<sup>nd</sup> appeal before the Commission which was received on 18.12.2020.

Seen the 2<sup>nd</sup> appeal dated 25.11.2020. The appellant submitted that he did not get satisfactory response against all the points of his RTI petition dated 24.06.2020. The appellant was directed to submit an affidavit describing his contention and also points of dissatisfaction over informations provided by the SPIO, Naharkatia Rev. Circle. Since the SPIO is unable to attend hearing on consecutive two days, therefore copy of the affidavit submitted by the appellant is being forwarded to CO, Naharkatia Rev. Circle. **The SPIO, Naharkatia Rev. Circle will peruse the contention of the affidavit of the appellant dated 09.04.2021 and furnish informations accordingly.**

**With the above directions, the 2<sup>nd</sup> appeal dated 25.11.2020 is hereby disposed of.**
