The appellant through his e-mail dated 21.09.2021 informs the Commission that he is unable to attend today's hearing and request to fix another date of hearing. It is pertinent to mention here that today's hearing was fixed on a prayer of the appellant dated 04.03.2021 but he is absent and had not furnished any certificate about his illness.

Shri Dipan Barman, ACS, SDO(S), o/o the Deputy Commissioner, Biswanath is present. He submits orally that the RTI application of Sri Manoj Kr. Sahani dated 28.01.2020 was transferred to Smti. Parijat Bhuyan, the then Addl. Deputy Commissioner of Biswanath with a request to furnish the sought for informations as all the informations relate to her academic qualification as well as selection in Assam Civil Services.

Perused the case record. The applicant submitted one petition under the RTI Act, 2005 dated 28.01.2020 before the SPIO, o/o the Deputy Commissioner, Biswanath seeking certain informations.

Seen the RTI application dated 28.01.2020. The applicant desires to get the informations about academic qualification of Smti. Parijat Bhuyan, ACS and ADC, Biswanath. Further, some personal informations were also sought for. From a plain reading of the application, it is observed that the sought for informations are not maintained in the DC's office, Biswanath. The SPIO instead of forwarding the application to the officer concerned i.e. Smti. Parijat Bhuyan it should have been transferred to the Personnel Department, Government of Assam for taking necessary action.

Seen the application and the action taken by the SPIO, o/o the DC, Biswanath. **The Commission directs the SPIO, o/o the DC, Biswanath to transfer the RTI application to Personnel (A) Department, Government of Assam, which is the custodian of records of ACS officers for taking necessary action.**

With the above directions, the complaint petition dated 02.11.2020 is hereby disposed of.
