Shri Samir Das, Deputy Director & SPIO of Directorate of Social Welfare, Assam is present. He submits one written statement bearing no. DSW(G)109/2019/83 dated 06.08.2021. It is submitted that the sought for informations has already been furnished to the appellant vide letter no. DSW(G)/109/2019/70 dated 04.03.2021. On query the appellant submits orally that he is in receipt of the said letter but in respect of his sought for informations under para 2 of his RTI petition dated 11.01.2021 is not satisfactory. He is satisfied with rest of the informations furnished to him. He submits that the SPIO of Directorate of Social Welfare, Assam denied informations sought for vide para 2 of his petition as per section 11 of the RTI Act, 2005. **The SPIO of Directorate of Social Welfare, Assam is hereby directed to furnish informations against para 2 of RTI petition dated 11.01.2021 within 10 days from the date of receipt of this order.**
