<u>ORDER</u>

The appellant Sri Uttam Mazumdar is present.

The SPIO, o/o the Superintendent of Police, Nagaon is absent without step although notice of hearing has been served properly.

The 1st appellate authority, o/o the Superintendent of Police, Nagaon has neither represented nor has submitted written statement in respect of action taken to dispose the 1st appeal petition dated 30.04.2021.

Perused the case record. The appellant submitted one application dated 16.02.2021 under the RTI Act, 2005 before the SPIO, o/o the SP, Nagaon seeking certain informations. He did not receive the desired informations within the stipulated period of time and thus submitted 1st appeal petition dated 30.04.2021. The FAA, o/o the SP, Nagaon also did not take any action nor arranged hearing to dispose the 1st appeal dated 30.04.2021. Being aggrieved, the appellant preferred 2nd appeal dated 28.06.2021 before the Commission.

It is observed that neither the SPIO nor the FAA, o/o the SP, Nagaon has taken action as per provision of the RTI Act, 2005. Therefore, the Commission directs the SPIO, o/o the Superintendent of Police, Nagaon to furnish the desired informations to the appellant within two weeks of receipt of this order and he will submit compliance report accordingly. The FAA, o/o the Superintendent of Police, Nagaon is directed to be careful to dispose of the 1st appeal petitions received in future.

With the above directions, the 2nd appeal dated 28.06.2021 is disposed of.
