**O R D E R**

The appellant Sri Debojit Barman is present.

The SPIO, o/o the Sarukhetri Dev. Block is absent although notice of hearing was served on 23.10.2021. The 1<sup>st</sup> appellate authority, Panchayat & Rural Dev. Deptt., Dispur has not submitted written statement.

Perused the case record. The appellant submitted one application dated 08.12.2020 under the RTI Act, 2005 before the SPIO, o/o the Sarukhetri Dev. Block seeking certain informations. He was not furnished with the sought for informations within the stipulated period of time, and therefore he submitted 1<sup>st</sup> appeal dated 29.01.2021 before the FAA of P & RD Deptt., Dispur. No action is seen to have been taken by the FAA for which the appellant submitted 2<sup>nd</sup> appeal dated 17.05.2021 before the Commission.

Seen the application dated 08.12.2020. From a plain reading of the petition, it is observed that the informations sought for are very much part of record to be maintained by the o/o the BDO, Sarukhetri Dev. Block. Therefore, **the Commission directs the SPIO, o/o the Sarukhetri Dev. Block to furnish the sought for informations within two weeks of receipt of this order.**

**With the above directions, the 2<sup>nd</sup> appeal dated 17.05.2021 is disposed of.**
