O R D E R

The appellant Md. Moshibor Rahman is present.

The SPIO, o/o the BEEO, Mankachar is absent. The 1st appellate authority, o/o the Deputy Commissioner, South Salmara Mankachar has not submitted written statement in respect of action taken to dispose the 1st appeal petition dated 02.03.2021.

Perused the case record. The appellant submitted one petition dated 25.01.2021 under the RTI Act, 2005 before the PIO, o/o the BEEO, Mankachar Education Block seeking certain informations. He did not receive the sought for informations within the stipulated period of 30 days and as such, submitted 1st appeal petition dated 02.03.2021 before the 1st appellate authority, o/o the DC, South Salmara-Mankachar. The FAA is stated to have taken no action to dispose the 1st appeal as per RTI Act, 2005. Being aggrieved, the petitioner preferred 2nd appeal dated 09.06.2021 before the Commission.

Seen the original RTI application dated 25.01.2021. The sought for informations are very much part of record to be maintained by the o/o the BEEO & school concerned i.e. Jhawdanga Academy MEM School. Therefore, **the Commission directs the SPIO, o/o the BEEO, Mankachar to furnish the sought for informations within three weeks of receipt of this order, and he will furnish a compliance report accordingly before the Commission. The FAA is directed to take appropriate and timely action whenever 1st appeal petition is received in future.**

With the above directions, the 2nd appeal dated 09.06.2021 is disposed of.
