The appellant Shri Harinarayan Pathak is present.

Shri Ritumoni Pachani, General Manager & SPIO, Assam Industrial Infrastructure Dev. Corporation is present.

Seen the written statement submitted by the SPIO vide letter no. AIIDC/3112/2021/2136 dated 09.09.2021. It is submitted that the informations sought by the petitioner is not specific for which it is not possible to find out documents from the diary no. 9926 dated 24.08.2015. Further, he submits that without mentioning of subject matter of Government letter no. CI.383/97/18 dated 06.02.1998 it is hard to search out action taken report and therefore he has issued a letter to the appellant to submit specific number and subject matter of the letter so as to enable him to trace it out. It is seen from the records that Shri Pathak submitted a letter dated 26.02.2021 to the SPIO of AIIDC which was received by the office on 01.03.2021 mentioning the subject of the Government letter of 06.02.1998 and requested to allow him to inspect the receipt register to find out the letter. The SPIO is not sure whether this has been received or not as the same is not available with him. A copy of the said letter of Shri Pathak is handed over to Shri Ritumoni Pachani today itself. **The Commission directs the SPIO of AIIDC to take action on the letter of 26.02.2021 of Shri Pathak and to furnish the required informations accordingly.**

With the above directions, the 2nd appeal dated 21.06.2021 is disposed of.
