1. The petitioner Sri Joydeb Das is present. The petitioner has filed his RTI application dated 5.10.2021 seeking some information relating to purchase of furniture in Gauhati University Hostel. On non receipt of any information, the petitioner filed 1st appeal before the First Appellate Authority of Gauhati University on 15.11.2021 and then he filed complaint petition on 23.4.2021 before the Commission.
2. The petitioner has submitted a written prayer before the Commission to convert his complaint petition into 2nd appeal.
3. The Public Authority is represented by Dr. Prasanta Barman, Deputy Registrar and PIO, Gauhati University.
4. The PIO of Gauhati University has submitted a written statement vide memo no. GU/PIO/RTI/2021/599 dated 29.12.2021 wherein it is mentioned that sought for information has already been furnished to the petitioner vide letter no. GU/PIO/RTI/2021/550 dated 18.11.2021.
Again, vide letter no. GU/PIO/RTI/2021/569 dated 1.12.2021 the purchase amount of 147 pieces of Hostel Wooden Chair which was corrected to Rs 4,37,619.00 instead of earlier given figure of Rs 84,37,619.00. On which the SPIO said that it was a typographical error and the copy of work order along supporting documents are also enclosed with the written statement.
5. The petitioner said that he is not satisfied with the reply given on the procedure adopted in disposal of the old furniture as no rule bound procedure is followed in disposal of old furniture.
6. The case is disposed off.
