**O R D E R**  
11/01/2022

1. The petitioner Sri Joydeb Das is present. The petitioner has filed his RTI petition before the PIO of Directorate of Vigilance & Anti-Corruption, Srimantapur, Guwahati on 24.8.2021 seeking following information:  
(a) Whether any anonymous complaint has been inquired or not, if inquired please furnish whether any EP deputed.
2. On not being satisfied with the reply from the PIO, the petitioner filed a complaint petition before the Commission on 23.11.2021 and accordingly the matter was taken up for hearing.
3. The petitioner has submitted a written prayer before the Commission to convert his complaint petition into 2<sup>nd</sup> appeal.
4. The Public Authority to be represented by SPIO of Directorate of Vigilance & Anti-Corruption is absent. However, the SPIO has submitted a written statement vide no. DGVA/RI/RTI/2022/129 dated 10.1.2022 wherein it is mentioned that a few anonymous/pseudonymous complaints received prior to 15.11.2017 and containing verifiable elements/materials are still under enquiry which are enquired by the Enquiry Officer at this Directorate ( ref. CVC No.98/DSP/9 dated 11.10.2002 enclosed as Annexure C and Govt. of Assam OM no. PLA(V)55/2003/12 dated 16.4.2004 para A(b) enclosed as Annexure D for ready reference).  
Anonymous complaints after the issue of Govt. OM No. PLA(V)264/2017/68 (ecf-20762) dated 15.11.2017 are not enquired into no matter even if it seemed to contain verifiable materials , but are filed.
5. The petitioner intimated that he has not received a copy of the written statement and he has prayed before the Commission to furnish a copy of it.  
Copy of the written statement is given to the petitioner.
6. In view of the above, the case is disposed off.
