O R D E R

- 1. The petitioner Sri Joydeb Das is present. The petitioner has filed his RTI application before the PIO, O/o the Deputy Commissioner of Police(Crime), Guwahati, Assam on 9.8.2021 seeking information as follows:
 - (a) Whether any action has been taken in pursuance of letter vide memo no. CID/Cell-XXI/R/ENQ No.29/2021 dated 9.4.2021, if yes please furnish a copy of the same along with case number.
- 2. On non-receipt of any information, the petitioner filed 1st appeal before the 1st Appellate Authority, O/o the Deputy Commissioner (Crime), Guwahati on 24.9.2021. Then the petitioner filed 2nd appeal before the Commission on 1.11.2021 and accordingly the matter was taken up for hearing.
- 3. The Public Authority is represented by Sri Hemanta Kumar Das, DCP (Admn.) accompanied by Sri Prasanta Saikia, DCP (Crime).
- 4. The SPIO has submitted a written statement vide no. ECP/RTI/472-21/1668 dated 8.12.2021 wherein it is mentioned that the case is registered and the case is under investigation. The petitioner says that it is almost completion of 3 months and the investigation to be expedited since the senior officers are present at the hearing, the Commission desires that case should be investigated expeditiously as per the provision of CrPC.
- 5. The case is disposed off.
