The appellant Sri Bhaskar Jyoti Das is present.

Smti. Monalisa Das, Asst. Executive Engineer (PHE) & SPIO, o/o the Chief Engineer (PHE), Sanitation, Hengrabari, Guwahati is present. She handed over one letter from the SPIO, o/o the CE (PHE), Water, Assam bearing no. PHE-337/RTI/2020/13380 dated 09.08.2021 received whereby it is submitted that the subject matter of the RTI petition of Sri Bhaskar Jyoti Das does not fall under the purview of his Establishment and as such, the same application has been transferred to the CE (PHE), Sanitation for taking necessary action vide letter no. PHE-337/RTI/202013053 dated 05.08.2021. The SPIO, o/o the CE (PHE), Sanitation submits orally that reply/informations against the RTI petition dated 05.01.2021 has already been furnished to the appellant. The appellant also admits that he is in receipt of one reply/information from the office of the CE (PHE), Sanitation but it is incomplete.

It is observed that in his appeal petition dated 22.03.2021, the appellant stated that no information had been received either from the SPIO or from the 1<sup>st</sup> appellate authority of CE (PHE),’s office which is not true.

**The SPIO, o/o the CE (PHE), Sanitation, Assam is directed to submit a written statement before next date of hearing. The FAA, o/o the CE (PHE), Sanitation, Assam is also directed to submit a written statement along with action taken report on the 1<sup>st</sup> appeal petition as per notice issued by the Commission vide letter no. SIC/KP(M).103/2021/18 dated 02.08.2021.**

**Meanwhile, the appellant will reply to the SPIO from whom he has received reply/informations against his RTI petition dated 05.01.2021 explaining about which information he desires to have.**

**Fix next date of hearing on 20.09.2021 at 12:30 PM. This order shall constitute notice for hearing.**
