**O R D E R**

16.08.2021

The appellant Sri Harinarayan Pathak is present.

Shri Razzaqul Hussain, Secretary & SPIO, Housefed, Assam is present and submits one written statement vide letter no. HFG.364/2019-20/Pt.II(H)/142 dated 12.08.2021. It is submitted that the RTI petition no. 1422 dated 27.02.2020 of Shri H.N. Pathak is stated to be not received by the office of the Housefed, Assam which is not true because the appellant has produced a copy of the application duly received by the office of the Housefed on 02.03.2020. The SPIO is warned not to submit untrue matter in future. The appellant submitted one application under the provisions of RTI Act, 2005 before the Secretary and SPIO of Housefed, Assam on 27.02.2020 seeking certain informations which was received by the office of the public authority on 02.03.2020. For non-receipt of the sought for informations within the stipulated period of time he moved 1<sup>st</sup> appeal on 19.05.2020 before the Managing Director & 1<sup>st</sup> appellate authority of Housefed. The 1<sup>st</sup> appellate authority organized a hearing of 1<sup>st</sup> appeal on 19.06.2020. It was ordered that no document was received by Housefed on 29.02.2020 as stated by the appellant. Further, it was stated that no specific mention of the authority from which the letter was sent or the subject mentioned therein for which no information could not be furnished as sought for. The appellant submitted today orally that he is satisfied with the replies/informations for his query number 2 and 3.

The public authority has denied to have received any letter on 29.02.2020 as stated by the appellant and the appellant fails to produce any document in support of his claim.

**Since the appellant is satisfied with the two replies/informations, it is ordered that the appellant may submit a fresh application seeking his desired informations clearly so that the public authority can furnish the informations accordingly.**

**The 2<sup>nd</sup> appeal is hereby disposed of.**
