The appellant Sri Harinarayan Pathak is present.

Shri Razzaqul Hussain, Secretary & SPIO, Housefed, Assam is present and submits one written statement vide letter no. HFG.364/2019-20/Pt.II(G)/37 dated 12.08.2021.

The appellant submitted one petition under the provisions of RTI Act, 2005 dated 11.02.2020 before the SPIO of Assam State Co-operative Housing Federation Ltd. seeking certain informations. The SPIO furnished informations vide his letter no. HFG.364/2019-20/Pt.II(G)/2 dated 27.02.2020. The appellant informs the SPIO that the informations furnished by him is incomplete and requested to furnish full informations as sought for. Subsequently he moved 1<sup>st</sup> appeal petition dated 26.06.2020 before the Managing Director and the 1<sup>st</sup> appellate authority of Housefed, Assam.

Seen the order of the FAA dated 08.09.2020 wherein it is stated that the informations had been furnished by the SPIO vide letter no. HFG.364/2019-20/Pt.II(D)/33 dated 02.02.2020. The SPIO fails to produce this letter today.

**The Commission directs the SPIO of Housefed, Assam to go through the RTI application of Shri Harinarayan Pathak dated 11.02.2020 minutely and to furnish the sought for informations properly within 10 days from the date of receipt of this order.**

**The 2<sup>nd</sup> appeal is hereby disposed of.**
