The appellant Sri Harinarayan Pathak is present.

Shri Razzaqul Hussain, SPIO & Secretary, Housefed, Assam is present and submits one written statement vide letter no. HFG.364/2019-20/Pt.II(D)/52 dated 12.08.2021.

The appellant submitted one petition under the provisions of RTI Act, 2005 dated 05.12.2019 before the SPIO of Assam State Co-operative Housing Federation Ltd. seeking certain informations. The SPIO furnished informations vide his letter no. HFG.364/2018-19/Pt.II(D)/2 dated 23.12.2019. The appellant informs the SPIO through a letter that the informations furnished to him are incomplete. The application was received by the office on 30.01.2020. The appellant did not get satisfactory reply and thus moved 1st appeal on 26.06.2020 before the FAA of Housefed. The FAA vide his order dated 08.09.2020 stated that informations had been furnished to the petitioner vide letter no. HFG.364/2019-20/Pt.II(D)/33 dated 02.02.2020. The SPIO fails to produce the copy of this letter today.

The Commission directs the SPIO, Housefed, Assam to go through the RTI petition minutely and furnish informations in full within 10 days from the date of receipt of this order.

The 2nd appeal is hereby disposed of.
