ORDER 09.11.2021

The appellant is absent.

The SPIO, o/o the Superintendent of Police, Dibrugarh is absent without step.

The 1^{st} appellate authority, o/o the Superintendent of Police, Dibrugarh has not submitted written statement in respect of action taken to dispose the 1^{st} appeal petition dated 13.11.2020. Notices have been served upon the SPIO and the 1^{st} appellate authority of SP's office, Dibrugarh on 21.10.2021.

Perused the case record. The appellant submitted one application dated 14.10.2020 under the RTI Act, 2005 before the SPIO, o/o the Superintendent of Police, Dibrugarh, seeking certain informations. The APIO & Addl. SP(HQ), Dibrugarh vide letter no. SPDBR-17013/3/2020-READER-officeofSP-Dibrugarh dated 11.11.2020 informed the appellant that the sought for informations could not be furnished as these are exempted under section 8(1)(a) of the RTI Act, 2005. Being dissatisfied with the informations so provided, the appellant submitted 1st appeal petition dated 13.11.2020 before the Superintendent of Police, Dibrugarh and 1st appellate authority.

It is observed that the FAA, o/o the Superintendent of Police, Dibrugarh did not dispose the 1st appeal petition as per provision of the Act. Therefore, copy of the 1st appeal is forwarded to the Superintendent of Police, Dibrugarh and 1st appellate authority with a direction to dispose of the 1st appeal as per provision of the Act.

With the above directions, the 2^{nd} appeal is hereby disposed of.
