The SPIO, o/o the Superintendent of Police, Dhemaji has submitted a report regarding disposal of the RTI petition dated 19.02.2021 of one Sri Ravindra Prasad Singh vide letter no. DMJ/CRM/RTI/2021/13178 dated 07.11.2021. It is submitted that the 1st appeal petition submitted by the appellant which has been received by the o/o the SP, Dhemaji on 09.04.2021 was mistakenly sent to Gogamukh Police Station for furnishing the sought for informations. It is also submitted that the application so received did not carry any enclosure for which no information could be provided with. The matter was informed to the applicant by the SP's office, Dhemaji vide letter no. DMJ/CRM/RTI/2021/5957 dated 18.05.2021 and subsequently on 03.06.2021 some documents were received from the applicant in which details of information sought for was enclosed. It is also informed that as per report of OC, Gogamukh Police Station dated 03.11.2021 no record was found available at Gogamukh Police Station regarding receipt of any application dated 19.02.2021 under RTI Act, 2005 submitted by the appellant by post. On receipt of documents received by the SP, Dhemaji on 03.06.2021 from the appellant informations were furnished to the appellant, through memo no. DMJ/CRM/RTI/7703 dated 30.06.2021.

Since the informations had already been furnished by the SP, Dhemaji to the appellant, as such, the 2nd appeal is disposed of.
