	<u>O R D E R</u> 17-12-2021

- 1. The appellant Shri Ajay Ashwiyana is absent. He has however sent an e-mail to the Commission dated 17.12.2021 where he has prayed for holding the hearing despite his absence.
- 2. The SPIO, O/o the Deputy Commissioner, Biswanath, is absent without any intimation.
- 3. From perusal of records it is seen that the appellant Shri Ajay Ashwiyana had submitted one RTI application to the SPIO, O/o the Deputy Commissioner, Biswanath, on 25.11.2020, seeking certain information apparently related to settlement of Fishery. On 12.04.2021 he submitted a complaint in the Commission stating that he had not been furnished with the informations by the Public Authority. The hearing of the complaint case which was twice postponed was re-fixed for today.
- 4. In view of the complaint submitted by the appellant Shri Ajay Ashwiyana, the SPIO, O/o the Deputy Commissioner, Biswanath, is directed to furnish the informations sought by the appellant within 21 (twenty-one) days from the date of receipt of this order if those are not exempted under provisions of the RTI Act, 2005, and not restricted by any court order. The informations shall be provided free of cost.
- 5. The SPIO, O/o the Deputy Commissioner, Biswanath, is directed to furnish the written statement explaining why penalty under Section 20 (1) of the RTI Act, 2005, shall not be imposed on him/her for his/her failure to furnish the information within the stipulated period. The written statement should reach the Commission within 15 (fifteen) days from the receipt of this order.
- 6. A copy of this order be marked to the Deputy Commissioner, Biswanath, for information and necessary action.
