The appellant Sri Charan Prit Singh is present.

Sri Hitesh Sarma Medhi, AEE, GMDA is present on behalf of Dev. Officer and SPIO of GMDA.

Md. Nazimuddin Ahmed, Deputy Commissioner i/c, GMC, Dispur zone is present.

Perused the case record. The appellant submitted one petition dated 11.03.2021 under the RTI Act, 2005 before the SPIO of GMDA and GMC seeking certain informations. He did not receive the sought for informations within the stipulated period of time for which he submitted 1<sup>st</sup> appeal dated 12.04.2021 before the 1<sup>st</sup> appellate authority of GMDA and GMC. Still he did not receive the desired informations for which he preferred 2<sup>nd</sup> appeal dated 27.07.2021 before the Commission.

The SPIO of GMDA submits written statement vide letter no. GMDA/RTI/2021/30/12 dated 25.11.2021. It is submitted that the sought for informations was furnished to the appellant vide letter no. GMDA/RTI/2021/30/3 dated 03.06.2021 and letter no. GMDA/RTI/2021/30/4 dated 10.06.2021. The representative of SPIO of GMC submits orally that the sought for informations had already been furnished to the appellant. On query the appellant submits that he is in receipt of the sought for informations although it is not satisfactory.

**Since the sought for informations has already been received by the appellant, as such, the 2<sup>nd</sup> appeal dated 27.07.2021 is disposed of.**
