**O R D E R**  
28.12.2021

The appellant Sri Harinarayan Pathak is present.

Smti. Sukanya Bora, SDO(S) and ASPIO, o/o the Deputy Commissioner, Kamrup(M) is present.

The SPIO, o/o the DC, Kamrup(M) has submitted written statement vide letter no.RTI/caseno.100/2021/659 dated 13.12.2021.

Perused the case record. The appellant submitted one petition dated 08.04.2021 under the RTI Act, 2005 before the SPIO, o/o the DC, Kamrup(M) seeking certain informations. He was not provided with the desired informations for which he submitted 1<sup>st</sup> appeal petition dated 15.06.2021 before the 1<sup>st</sup> appellate authority and DC, Kamrup(M). Still he did not receive the sought for informations, as such, he preferred 2<sup>nd</sup> appeal dated 02.08.2021 before the Commission.

The SPIO in the written statement submitted that a date for hearing of 1<sup>st</sup> appeal has been fixed on 14.12.2021. On query, the appellant admits that hearing for 1<sup>st</sup> appeal was fixed on 14.12.2021 but he is yet to receive the copy of the order. The ASPIO has handed over the copy of the order dated 14.12.2021 in respect of 1<sup>st</sup> appeal case whereby the Senior Sub-Registrar, Registry Branch, Kamrup (M) was directed to make arrangement within thirty days for the appellant to trace out informations sought for. The appellant further submits that he has gone for inspection of the records in the office of the Senior Sub-Registrar but could not locate records of the sought for informations as short period of time was given to search the same.

Seen the RTI petition dated 08.04.2021. The appellant prayed to furnish a copy of the Registered Sale Deed dated 04.03.1958 in respect of land measuring 43 bighas, 3 kathas, 4 lessas at Bamunimaidam within Kamrup district. The Senior Sub-Registrar, Kamrup(M) requested the appellant to submit the name of seller and purchaser, Dag and Patta no. of the land in respect of sale deed executed in 04.03.1958. The number of deeds executed in far 1958 may be very few and the Senior Sub-Registrar should have found the copy of the deed through his staff instead of seeking particulars from the appellant. **It is also observed that the appellant is a senior citizen and it may not be possible for him to search out the required**

informations from the record of the Registry branch within a very short period of time. Since the application had been transferred to the Senior Sub-Registrar, Kamrup(M) and deemed PIO, therefore, he is directed to furnish the sought for informations within two weeks of receipt of this order to the appellant, free of cost.

With the above directions, the 2<sup>nd</sup> appeal dated 02.08.2021 is disposed of.
