**O R D E R**  
 27.12.2021

The appellant Sri Joydeb Das is present.

Sri Gobin Ch. Mili, Addl. Director-cum-SPIO, O/o the Director, WPT & BC, Assam is present. Md. Sahjamal Uddin Ahmed, Research Asstt. is also present.

The Directorate of WPT & BC, Assam vide its letter no. DW/RTI/239/2016/Pt-I dated 23.12.2021 informs that the RTI application dated 12.04.2021 of Sri Joydeb Das has been transferred to Sri Prabin Kr. Choudhury, Deputy Secretary, Government of Assam and SPIO to furnish the required informations directly to the petitioner. The SPIO submits orally that the sought for informations i.e. proposal for release of ceiling amount in respect of Solar Home Light, GCI Sheet, Seeds, Bio-Organic Soil, Paddy Reaper, Power Tiller, Exercise Book, Sports Uniform Kits, Agricultural Kits, Water filter, tablet PC and sewing machine during the period 2018-19, 2019-20 and 2020-21 are although submitted by the Directorate but the informations as sought for in a checklist is not maintained by the Directorate. It is done by the administrative department and submitted to the Financial (budget) Department for release of ceiling amount and for this reason, the application has been transferred.

It is observed that the Directorate of WPT & BC, Assam transferred the application after almost six months of receipt of the RTI application. Further, the letter has not been addressed properly and it is seen that it was addressed to one Deputy Secretary to the Government of Assam without mentioning the name of the department. **It is, therefore, directed that the SPIO, Directorate of WPT & BC, Assam will furnish the informations as maintained in his office, and transfer the application properly to the Deputy Secretary to the Government of Assam and the SPIO of WPT & BC, Assam with a request to furnish the desired informations as prayed for in the application. He will also ensure that the desired informations are furnished within next two weeks of receipt of this order.**

**With the above directions, the 2<sup>nd</sup> appeal dated 29.07.2021 is disposed of.**
