O R D E R

The appellant Sri Joydeb Das is present.

Sri Dharanidhar Das, Under Secretary to the Government of Assam and SPIO, Personnel (A) Deptt. is present and submits written statement vide letter no. AAP.95/2020/131 dated 09.12.2021.

Perused the case record. The appellant submitted one petition dated 19.05.2021 under the RTI Act, 2005 before the PIO of Personnel (A) Deptt., Government of Assam seeking certain informations. The same was received by the Department on 09.06.2021 and was forwarded to the Addl. Secretary of Personnel (A) Deptt. and deemed PIO vide U.O. no. AAP.95/2020/27 dated 17.06.2021 to assist the PIO by furnishing the sought for informations. The petitioner submitted another application dated 19.08.2021. The deemed PIO vide its letter no. U.O.AAP.105/2021/51 dated 24.09.2021 informed the PIO of Personnel (A) Deptt that views of Judicial Department will be taken and informations will be furnished thereafter only and this development has already been informed to the petitioner through letter no. AAP.95/2020/100 dated 20.09.2021. He further submits that the department has decided to furnish the available informatios to the petitioner within next one month.

It is observed that the department may require views of Judicial Department to furnish the sought for informations but there should be time limit in furnishing the informations as per provision of the RTI Act, 2005. However, as the SPIO has submitted in writing that the Department will furnish the informations within one month, therefore he is directed to furnish the sought for informations within two weeks of receipt of this order.

With the above directions, the 2nd appeal dated 20.09.2021 is disposed of.
