**O R D E R**

24.12.2021

There are as many as five cases for hearing today where Sri Durgeswar Das is the appellant. He is absent in all the cases without step. He seems to have lost interest in his appeal/informations.

Sri Bijoy Kr. Sarma, Assistant Engineer and SPIO, Pakhimoria Dev. Block is present to represent the 1<sup>st</sup> appellate authority and Block Dev. Officer, Pakhimoria Dev. Block.

Smti. Pallabi Borah, i/c Secretary, Tulshi Deori GP is present and submits written statement vide letter no. TGP/RTI-3/2021-22/369 dated 23.12.2021.

The appellant submitted 2<sup>nd</sup> appeal dated 21.02.2018 before the Commission and his contention was that the BDO and 1<sup>st</sup> appellate authority, Pakhimoria Dev. Block did not organize hearing for his 1<sup>st</sup> appeal dated 15.12.2017.

Seen the written statement submitted by the SPIO and Secretary, Tulshi Deori GP as well as that of SPIO, Pakhimoria Dev. Block. It is submitted that the FAA, Pakhimoria dev. Block organized a hearing for 1<sup>st</sup> appeal and notice was issued accordingly fixing date of hearing on 28.02.2018. But the appellant absented himself from the hearing and the 1<sup>st</sup> appeal was disposed of with no order. However, the sought for information was furnished to the appellant vide letter no. TGP/RTI-3/2017-18/145 dated 13.03.2018.

From the above, **it is observed that the appellant has misled the Commission by giving false informations that no hearing for 1<sup>st</sup> appeal was organized. Therefore, the 2<sup>nd</sup> appeal dated 21.02.2018 is disposed of with no order.**
