O R D E R

There are as many as five cases for hearing today where Sri Durgeswar Das is the appellant. He is absent in all the cases without step. He seems to have lost interest in his appeal/informations.

Sri Bijoy Kr. Sarma, Assistant Engineer and SPIO, Pakhimoria Dev. Block is present to represent the 1st appellate authority and Block Dev. Officer, Pakhimoria Dev. Block and submits written statement vide letter no. PDB/50/RTI/2020-21/50 dated 23.12.2021.

Sri Ritumoni Baruah i/c Secretary, Bhutai Pathari GP is present and submits written statement vide letter no. BPGP/RTI/1/2021-22 dated 23.12.2021.

Seen the case record and 2nd appeal petition dated 21.02.2018. The contention of the appellant was that the 1st appellate authority and BDO, Pakhimoria Dev. Block did not organize hearing against his 1st appeal petition dated 15.12.2017.

Seen the written statement submitted by the SPIO and Secretary, Bhutai Pathari GP as well as that of SPIO, Pakhimoria Dev. Block. It is observed that hearing for 1st appeal against his petition dated 11.11.2017 was organized by the BDO and the FAA, Pakhimoria Dev. Block fixing date of hearing on 08.03.2018 and notices were served to all concerned accordingly. The GP Secretary was present but the appellant was absent on the date of hearing. As such, **the contention of the appellant is found to be untrue and misleading. It is also observed that the appellant Sri Durgeswar Das submits 2nd appeal petition time and again and misleads the Commission by putting allegations against the SPIO and the FAA of different public authority. Further, it is also observed that the sought for informations had already been furnished to the appellant vide letter no. PBGP/RTI/1/2017-18 dated 13.03.2018.**

In view of the above, the 2nd appeal dated 21.02.2018 is disposed of with no order.
