**O R D E R**

24.12.2021

There are as many as five cases for hearing today where Sri Durgeswar Das is the appellant. He is absent in all the cases without step. He seems to have lost interest in his appeal/informations.

Sri Bijoy Kr. Sarma, Assistant Engineer and SPIO, Pakhimoria Dev. Block is present to represent the 1<sup>st</sup> appellate authority and Block Dev. Officer, Pakhimoria Dev. Block and submits written statement vide letter no. PDB/50/RTI/2020-21/51 dated 23.12.2021.

Sri Dipak Kr. Bhatta, Secretary, Deodhar GP is present and submits written statement vide letter no. DGP/RTI/4(A)/2020-21/57-59 dated 23.12.2021.

Seen the case record and 2<sup>nd</sup> appeal petition dated 19.02.2018. The contention of the appellant was that the 1<sup>st</sup> appellate authority and BDO, Pakhimoria Dev. Block did not organize hearing against his 1<sup>st</sup> appeal petition dated 15.12.2017.

Seen the written statement submitted by the SPIO and Secretary, Deodhar GP as well as that of SPIO, Pakhimoria Dev. Block. It is observed that hearing for 1<sup>st</sup> appeal against his petition dated 11.11.2017 was organized by the BDO and the FAA, Pakhimoria Dev. Block against 1<sup>st</sup> appeal petition dated 15.12.2017 and notices were served to all concerned vide letter no. PDB/RTI/50/2017-18/1872 dated 26.02.2018 but the appellant Sri Durgeswar Das was not present during the time of hearing, as such, his contention in the 2<sup>nd</sup> appeal is totally false and misleading. It is also observed that the appellant submits 2<sup>nd</sup> appeal petition before the Commission with untrue informations and thus misleads the Commission. **It is also observed that the sought for informations were furnished to him vide letter no. DGP/RTI/2017-18/3 dated 15.03.2018 by registered post. He did not inform the Commission about the receipt of the sought for informations and waste valuable time of the Commission as well as the SPIO of Deodhar GP and BDO, Pakhimoria Dev. Block. Therefore, the 2<sup>nd</sup> appeal dated 19.02.2018 is disposed of with no order.**
