Sri K. Eshan Singh, ACS, SPIO & Circle Officer, Nagaon Rev. Circle is present and submits written statement vide letter no.NSRC.07/RTI/2020/312 dated 13.04.2021. He is assisted by Sri Krishna Kamal Bora, Senior Assistant.

Seen the case record and 2nd appeal dated 25.05.2018. The contention of the appellant was that the Deputy Commissioner, Nagaon & 1st appellate authority did not organize hearing against his 1st appeal petition dated 10.04.2018.

From the written statement submitted by the Circle Officer, Nagaon Rev. Circle, it is observed that the DC, Nagaon and FAA organized hearing against his 1st appeal petition, and as per order of the FAA, the SPIO, Nagaon Rev. Circle had already furnished the sought for informations. **Therefore, it is evident that the contention of the 2nd appeal petition is untrue and misleading.
