The appellant Sri Harinarayan Pathak is present.

Sri Biswajit Singha, SPIO, Assam Information Commission is also present.

Perused the case record. The appellant Shri H.N. Pathak submitted one petition dated 28.10.2020 under the RTI Act, 2005 before the SPIO of Assam Information Commission seeking certain informations. The SPIO vide its letter no. SIC/SPIO/17/2020/73 dated 27.11.2020 had given a reply to the petitioner in response to his petition dated 28.10.2020. Since the SPIO had given a reply to the appellant against his petition dated 28.10.2020 but did not furnish the sought for informations, the applicant submitted 1st appeal dated 11.12.2020 under section 19(1) of the RTI Act, 2005 before the Secretary and 1st appellate authority of Assam Information Commission. The FAA arranged hearing against the 1st appeal fixing date of hearing on 29.12.2020 where the appellant as well as the respondent were present. While passing this order the FAA may have misread the reply of the SPIO and the points of dissatisfaction of the appellant was not looked into.

Seen the RTI petition dated 28.10.2020. The sought for informations are very much part of record and as such, it falls under the definition of informations. **Therefore, the SPIO, o/o the Assam Information Commission is directed to furnish the sought for informations to the applicant within ten days of receipt of this order.**

The 2nd appeal dated 19.02.2021 is disposed of.
