O R D E R

The appellant is absent. However, he has submitted written statement vide his letter no. nil dated 20.12.2021 in respect of Commission's order dated 01.11.2021.

Sri Ashim Swargiary, Commandant, Armed Police Training Centre, Dergaon has authorized Sri Rajen Konwar APS, Adjutant, Armed Police Training centre, Dergaon and Sri Pranob Kr. Gogoi, Senior Assistant to attend today's hearing.

Seen the written statement submitted by the appellant. It is submitted that replies given by the PIO of APTC, Dergaon vide letter no. APTC/C/RTI/2021/3850 dated 21.12.2021 in respect of point numbers 2, 8 and 9 of his petition dated 06.01.2021 that the personal details cannot be provided as per provision of Section 8(1) of the RTI Act, 2005. He also submits that if the same can't be furnished as per provision of the Act then he has no objection but if the same is not barred by Section 8(1)(j) of the Act, then the informations should be furnished.

Seen the RTI petition dated 06.01.2021 and informations furnished on 17.03.2021. The reply of point number 2 of the petition is that personal details of third party can't be provided as per provision of section of 8(1)(j) of the Act. **The appellant sought the names, addresses and Mobile numbers of all the trainees of batch no. 116R/C and the reply provided with is upheld as sought for informations are personal informations of third party and no cause of action is stated by the appellant to secure third party personal informations. Point number 8 can't be understood and as such, the PIO need not require to give reply for the same. In respect of point number 9, the question was whether Sri Pronab Kr. Gogoi, Senior Assistant is serving on deputation or permanent staff of APTC, Dergaon. The PIO should give reply for the same within next two weeks.**

With the above directions, the petition dated 09.04.2021 is disposed of.
