**ORDER**

21.12.2021

The appellant is absent without step.

The SPIO, o/o the Deputy Commissioner, Hailakandi is absent without step.

The 1<sup>st</sup> appellate authority, o/o the DC, Hailakandi has not submitted written statement in respect of action taken to dispose the 1<sup>st</sup> appeal petition dated 26.08.2019.

The case is taken up for hearing in the absence of both parties as the 2<sup>nd</sup> appeal is pending since 03.10.2019.

Perused the case record. The appellant submitted one petition dated 17.07.2019 under the RTI Act, 2005 before the SPIO of DC's office, Hailakandi seeking certain informations. The SPIO transferred the RTI application to the Asstt. Director i/c , FCS & CA branch, DC's office, Hailakandi through letter no. HRI.1/Pt-II/2018/52 dated 18.07.2019. The Asstt. Director of FCS & CA branch had transferred the petition to the Secretary of M/s Jamira GPSS Ltd., M/s Asinakhal GPSS and M/s Mohammadpur Niz Vernerpur GPSS Ltd. with a direction to furnish the sought for informations to the appellant directly vide letter no. HS.29/2019/72 dated 25.07.2019. No information was received by the petitioner within the stipulated period of time, and as such, he submitted 1<sup>st</sup> appeal petition dated 26.08.2019 before the DC, Hailakandi and 1<sup>st</sup> appellate authority. Still he did not receive the desired informations for which he preferred 2<sup>nd</sup> appeal dated 03.10.2019 before the Commission.

Seen the petition dated 17.07.2019. The sought for informations are very much part of record maintained by the concerning GPSS and the RTI petition had already been transferred to the three GPSS by the Asstt. Director i/c , FCS & CA, Hailakandi. **Therefore, the SPIO of DC's office, Hailakandi is directed to ensure that the sought for informations are furnished to the appellant within ten days of receipt of this order, free of cost.**

**With the above directions, the 2<sup>nd</sup> appeal dated 03.10.2019 is disposed of.**
