Perused the case record. The appellant submitted one petition dated 16.02.2018 under the RTI Act, 2005 before the BDO, Udali dev. Block seeking certain informations. He did not receive the sought for informations within the stipulated period of time for which he submitted 1st appeal petition dated 23.03.2021 before the Project Director, DRDA, Nagaon. The CEO, Nagaon Zilla Parishad and 1st appellate authority organized hearing for the 1st appeal petition and disposed the same through order dated 11.04.2018 directing all respondents to provide the informations free of cost on or before 25.04.2018. Still the appellant did not receive the desired informations for which he preferred 2nd appeal dated 05.06.2018 before the Commission. The BDO, Udali Dev. Block vide its letter no. ODB/RTI-06/2019-20/444 dated 04.12.2021 submits that the sought for informations had already been furnished to the appellant through registered post.

Since the sought for informations had already been furnished, and the appellant is not present to raise any contention, if there be any, as such the 2nd appeal dated 05.06.2018 is disposed of.
