O R D E R

The appellant Sri Siddheswar Barman is present.

The Deputy Commissioner, Chirang has authorized Md. Wadiul Islam, SDO(Sadar), Chirang to represent him in today's hearing. Accordingly he is present and submits written statement vide letter no. CHR-RTI-1/21/76 dated 25.11.2021. As authorized by the BDO, Borobazar TD Block Sri Moidul Islam, Assistant BDO(P) is present in lieu of APIO. It is submitted that the APIO of the Borobazar TD Block is advised not to attend today's hearing as her mother is stated to be tested positive for Covid-19. Sri Promod Basumatary, Accountant, Borobazar TD Block is also present. The Asstt. BDO vide its letter no. BDB.2/RTI-4/2019-20/B/15 dated 25.11.2021 submits that the sought for informations could not be furnished to the applicant as his petition dated 10.03.2021 was misfiled. However, he has received the copy of the application along with the letter of Deputy Commissioner, Chirang bearing no. The appellant received a copy of the letter during the time of hearing and admits that he is satisfied with the informations so received.

Since the appellant has received the sought for informations to his satisfaction, as such, the 2nd appeal dated 11.08.2021 is disposed of.
