**O R D E R**

The appellant is absent.

Smti. Urmimala Borah Borthakur, Principal, Kharupetia Higher secondary School is present. She is assisted by Sri Abdul Ali, Vice President of SMDC.

Perused the case record. The appellant submitted one petition dated 12.03.2020 under the RTI Act, 2005 before the SPIO of Inspector of Schools, Darrang Dist. Circle seeking certain informations. He did not receive the desired informations for which he submitted 1<sup>st</sup> appeal petition dated 09.06.2020 before the Inspector of Schools, Darrang Dist. Circle, Mangaldai. Meanwhile, the Principal of Kharupetia H. S. School wrote a letter to the petitioner vide letter no. KHSS/RTI/SA/2020/446 dated 12.01.2021 apprising the appellant her inability to furnish the sought for informations for prevailing situation of Covid-19. However, he was requested to visit the school to collect the documents vide letter no. KHSS/RTI/SA/2020/419 dated 10.10.2020. Instead of collecting the informations, the applicant preferred 1<sup>st</sup> appeal petition which was also transferred to the school authority by the Inspector of Schools, Darrang Dist. Circle, Mangaldai. The Principal then informed the petitioner that she was not in a position to furnish the informations as the school was declared as a quarantine centre for Covid-19. The appellant preferred 2<sup>nd</sup> appeal dated 06.04.2021 before the Commission.

Seen the letter of Md. Chakman Ali dated 08.11.2021. It is submitted that he has been suffering from various ailment and as such, he has withdrawn the RTI petition dated 12.03.2020 as well as his 2<sup>nd</sup> appeal dated 06.04.2021 and requests the Commission to dispose of the appeal petition.

**Since the petitioner himself withdraws the appeal petition, and prays to dispose of the appeal, as such, the 2<sup>nd</sup> appeal dated 06.04.2021 is disposed of.**
