**O R D E R**

25.11.2021

The appellant Sri Joynal Abedin is present.

The SPIO of Dhubri Rev. Circle is absent without step.

The 1<sup>st</sup> appellate authority of Dhubri Rev. Circle has not submitted written statement in respect of action taken to dispose the 1<sup>st</sup> appeal petition. The Deputy Commissioner, Dhubri and FAA under the RTI Act, 2005 vide its letter no. DFC.01/2021/RTI/Pt-III/4 dated 23.11.2021 informs the Commission that the 1<sup>st</sup> appeal petition dated 26.04.2021 was received on 01.09.2021 and it was transferred to the Circle Officer, Dhubri vide letter no. DFC.01/2021/RTI/Pt-I/163 dated 10.09.2021 as the CO, Dhubri Rev. Circle himself is the FAA on the same matter. From the documents submitted by the appellant along with his 2<sup>nd</sup> appeal petition dated 27.07.2021, it is seen that the 1<sup>st</sup> appeal petition was received by the DC's office, Dhubri on 26.04.2021 instead of 01.09.2021. The DC, Dhubri will inquire the matter. Further, DC, Dhubri through the same letter submits report on the 1<sup>st</sup> appeal petition of Sri Joynal Abedin but request the Commission to drop the 2<sup>nd</sup> appeal against 1<sup>st</sup> appeal filed by Sri Anowar Ali which could not be understood. He is directed to verify this matter.

From the materials available in the case record and as per submission of the appellant, it is seen that no information has been furnished by the SPIO of Dhubri Rev. Circle and the FAA also has not taken any step to dispose the 1<sup>st</sup> appeal petition. **Therefore, DC, Dhubri will furnish the name and designation of SPIO and the FAA of Dhubri Rev. Circle for taking action from this end. He will submit the informations within seven days of receipt of this order.**

**Fix next date of hearing on 21.01.2022 at 11:30 AM. This order shall constitute notice for hearing.**
