The appellant Sri Brojen Barman is present.

Sri Simanta Kr. Deka, i/c Inspector of Schools, Nalbari Dist. Circle and 1st appellate authority and Sri Pradip Kr. Bhattacharjee, SPIO, o/o the Inspector of Schools, Nalbari are present. The FAA has submitted a written statement vide letter no. IS/NDC/Nal/RTI/1/2021/3935 dated 20.11.2021. It is submitted that the sought for informations/documents are not available in his office for which he has transferred the RTI application of Sri Brojen Barman dated 18.11.2020 to the head of the private High Schools of the district vide letter no. IS/NDC/Nal/RTI/1/2021/4017 dated 01.01.2021.

Seen the application dated 18.11.2020. From a plain reading of the same, it is observed that informations on point number 1, part information of point number 2, and 4, 5, 6 and 7 should be maintained as record in the office of the Inspector of Schools, Nalbari. Although he has transferred the RTI petition to the private High Schools of the district, it is the duty of the Inspector of Schools, Nalbari being the controlling authority in respect of Secondary Schools to furnish informations of the points stated above. If the same are not available in his office at present, then he will compile the same within ten days and furnish the informations within three weeks from receipt of this order.

It is also observed that the petitioner sought for some informations but the language of the application does not make any sense as to what information he requires. Therefore, the Commission directs the petitioner only to seek pertinent informations in future as it is assumed that irrelevant questions may perturb the officials who deals with the subject.
