**O R D E R**  
22.11.2021

The appellant Md. Nawman Islam is present.

The SDO (Sadar) and SPIO, o/o the Deputy Commissioner, Nagaon has submitted a written statement vide letter no. NDC(RTI Cell)03/2020/100 dated 17.11.2021. It is submitted that the RTI petition dated 06.03.2021 addressed to the SPIO, o/o the DC, Nagaon was transferred under section 6(3) of the RTI Act, 2005 to the BDO, Lawkhowa Dev. Block vide letter no. NDC(RTI Cell)02/2021/01 dated 30.07.2021 with a direction to furnish the desired informations to the appellant within the stipulated period of time. The petitioner was informed accordingly. However, for non-receipt of the informations, the petitioner submitted 1<sup>st</sup> appeal petition dated 14.05.2021 before the 1<sup>st</sup> appellate authority of the DC's office, Nagaon. On receipt of the same on 07.06.2021, the SPIO, DC's office, Nagaon again forwarded the same to the BDO, Lawkhowa Dev. Block for taking necessary action but the BDO did not furnish the sought for informations for which the appellant preferred 2<sup>nd</sup> appeal dated 29.07.2021 before the Commission.

From a plain reading of the RTI petition dated 06.03.2021, it observed that the sought for informations are very much part of the record to be maintained by the BDO's office, Lawkhowa Dev. Block. **Therefore, the Commission directs the SPIO of Lawkhowa Dev. Block to furnish the desired informations to the appellant, within seven days of receipt of this order, free of cost. No compliance of the order in the stipulated time fixed will attract penalty under section 20 of the RTI Act, 2005.**

**With the above directions, the 2<sup>nd</sup> appeal dated 29.07.2021 is disposed of.**
