The appellant Md. Anowar Ali is present.

The SPIO, o/o the SDO(C), Bilasipara has submitted a written statement through e-mail vide letter no. BRTI1/2021/351 dated 29.11.2021.

Perused the case record. The appellant submitted one petition dated 04.12.2020 under the RTI Act, 2005 before the PIO of o/o the SDO (C), Bilasipara seeking certain informations. For non-receipt of the desired informations, he submitted  $1^{st}$  appeal petition dated 06.01.2021 before the  $1^{st}$  appellate authority, o/o the Deputy Commissioner, Dhubri. He did not receive the desired informations and it is stated that no action was taken by the  $1^{st}$  appellate authority also. Therefore, he submitted  $2^{nd}$  appeal petition dated 04.06.2021 before the Commission.

Seen the written statement submitted by the SPIO, o/o the SDO(C) Bilasipara. It is submitted that the informations sought by the appellant relates to Bilasipara Rev. Circle for which the said application was transferred to the Circle Officer, Bilasipara for furnishing the required informations within the stipulated period of time under the RTI Act, 2005. The appellant filed 1<sup>st</sup> appeal petition before the FAA, o/o the DC, Dhubri on 06.01.2021. The Circle Officer, Bilasipara furnished the informations vide letter no. BPC.3/2020/PT-II/128 dated 11.02.2021 by post.

Since the sought for informations has already been furnished, the SPIO, o/o the Bilasipara Rev. Circle requests to dispose of the case.

On query the appellant submits orally that he has not received any informations from the CO, Bilasipara against his petition dated 04.12.2020. The Circle Officer & SPIO, Bilasipara Rev. Circle is directed to provide the appellant with a copy already furnished informations by hand within seven days of receipt of this order.

The 2<sup>nd</sup> appeal dated 04.06.2021 is disposed of.
