O R D E R 27/01/2022

- The petitioner Sri Pradip Kumar Saikia has filed one RTI petition before the PIO,O/o the Deputy Commissioner, Dibrugarh on 11.9.2021 seeking some information relating to name of the person or organization or company who forcefully encroached/occupied the petitioner's land measuring 16-2K-OL vide P.P.No.42 lot No. 5 near Moran Revenue Circle Office.
- 2. On non receipt of any information, the petitioner filed 1st appeal before the 1st Appellate Authority, O/o the Deputy Commissioner, Dibrugarh on 28.10.2021 and then he filed 2nd appeal before the Commission on 13.12.2021.

Accordingly, the matter was taken up for virtual hearing.

- 3. The SPIO, O/o the Deputy Commissioner, Dibrugarh did not come online on video conferencing due to his Covid 19 affliction that has been intimated vide letter no. DMJ/RTI/2ndAppeal/46/2021/8 dated 24.1.2022
