## O R D E R 17/01/2022

- 1. The petitioner Smti Jyotika Deka has filed his RTI application before the SPIO, O/o the Director of Secondary Education, Guwahati on 6.9.2021 seeking following information:
  - (a) Particulars of information sought -
    - State Scrutiny Committee eligible teacher/tutor list of Vidya Bharati Senior Secondary School under the Provincialisation Act 2017 and the Amendment Act 2018.
    - Reason for not inclusion in the Provincialisation list of left out teachers/tutors of Vidya Bharati Senior Secondary School.
- 2. On non receipt of any information, the petitioner filed 1<sup>st</sup> appeal before the 1<sup>st</sup> Appellate Authority, Office of the Director of Secondary Education, Kahilipara, Guwahati on 27.10.2021 and then she filed 2<sup>nd</sup> appeal before the Commission on 22.12.2021.

Accordingly, the matter was taken up for virtual hearing.

- 3. The SPIO & Deputy Director, Office of the Director of Secondary Education, Kahilipara, Guwahati submitted a written statement vide no. PC/RTI/15/2021/6 dated 13.1.2022 wherein it is mentioned that sought for information has already been furnished to the petitioner on 30.12.2021.
- 4. In response to the written statement, the petitioner said that she has not received any information.
- 5. In light of it, the SPIO is ordered to give specific reply to the petitioner once again through registered post within seven days.

If the petitioner is not satisfied after receipt of the reply, she may move before the Commission for physical hearing.
