O R D E R

1. The petitioner Sri Mrinal Kalita has filed one RTI petition before the SPIO, O/o the Deputy Commissioner, Kamrup Metro on 10.9.2020 seeking following information:
(a) Furnish information regarding the status of file vide KRM(M)/353/2015 in connection with an application and objection in the land sale Branch.
2. In reply to that, the Office of Deputy Commissioner, Kamrup Metro passed an order dated 9.9.2021 wherein the Additional Deputy Commissioner, Land Revenue (Land Sale) Branch, Kamrup (M) was instructed to submit the required information directly to the petitioner within one week.
3. On non receipt of any information, the petitioner filed 1st appeal before the 1st Appellate Authority, Office of the Deputy Commissioner, Kamrup Metropolitan District on 5.11.2020 and then he filed 2nd appeal before the Commission on 18.12.2021.
Accordingly, the matter was taken up for virtual hearing.
4. The SPIO of the Office of Deputy Commissioner, Kamrup Metropolitan District sent a written statement vide no. RTI Case No. 181/2020/61 dated 27.1.2022 which is taken into records.
5. The petitioner did not come online on video conferencing.
6. However, the SPIO Smti Kalpana Deka, ADC, Dibrugarh came online on video conferencing and said that the sought for information is not yet given allegedly due to different reasons.
7. The Commission has decided to hear the matter again physically after the Covid situation improves.
