O R D E R 24/01/2022

- 1. The petitioner Sri Joydeb Das has filed his RTI petition on 23.8.2021 before the PIO of Directorate of Social Welfare, Uzanbazar, Guwahati seeking following information:-
 - (a) Whether Director of Social Welfare has procured Micronutrient Fortified Energy Dense during the period 2018-19 if yes please furnish following details:
 - Please furnish a copy of work order, Comparative Statement, Bill, Released Order, Sanction letter and fund involved and details of expenditure.
 - Please furnish a copy of UCs/SOEs.
- 2. On non receipt of any information, the petitioner filed 1st appeal before the 1st Appellate Authority of Directorate of Social Welfare on 5.10.2021 and then he filed complaint petition before the Commission on 22.12.2021.

Accordingly, the matter was taken up for virtual hearing.

- 3. The petitioner has sent an email dated 21.1.2022 wherein he has mentioned that he has received the sought for information from the SPIO of Directorate of Social Welfare, Uzanbazar, Guwahati.
- 4. The SPIO of Directorate of Social Welfare has also submitted a written statement vide no. DSW(G)15/2019/Pt-II/26 dated 20.1.2022 which is taken into records.
- 5. Since the sought for information has already been furnished, the complaint petition dated 22.12.2021 is disposed off.
