The appellant is absent without step.

The 1<sup>st</sup> appellate authority, o/o the Dhemaji Rev. Circle has not submitted written statement in respect of action taken to dispose of 1<sup>st</sup> appeal petition dated 10.09.2019. Notice of hearing is seen to have been served upon the appellant, the SPIO and the 1<sup>st</sup> appellate authority of Dhemaji Rev. Circle.

Perused the case record. The appellant submitted one petition dated 20.07.2019 under the RTI Act, 2005 before the SPIO of Dhemaji Rev. Circle seeking some informations.
