The appellant is absent. However, through his letter dated 17.01.2022 he informs the Commission that he has been invited for inspection of the sought for informations by a letter issued by the DAO, Nalbari dated 21.08.2021 but the DAO, Nalbari did not respond while he was contacted over telephone. Therefore, he requests the Commission to pass necessary order for inspection of lists and APRs and to dispose of the 2nd appeal accordingly.

Dr. Munindra Sarma, Senior Agril. Dev. Officer (PP) and ASPIO, o/o the Dist. Agriculture Officer, Nalbari is present and submits written statement vide letter no. DAO(N)/RTI/2020-21/1374 dated 27.12.2021. It is submitted that the sought for informations had already been furnished to the appellant vide letter no. DAO(N)/RTI/2020-21/1044 dated 21.08.2021, and the lists of beneficiary was also ready for delivery and the appellant was requested to collect the same but the appellant did not collect the beneficiary lists and APRs of distribution of mustard seeds of different varieties like Pitambari, PM-25 and NRCHB-101 under the scheme Disaster Management and RKVY for the period 2019-20.

It is observed that part of the sought for informations had already been furnished by the o/o the DAO, Nalbari to the appellant and he was requested to collect the photocopies of APRs in respect of distribution of different varieties of seeds under the scheme Disaster Management and RKVY during the period 2019-20. **The appellant has not collected the same and therefore the Commission directs the appellant to collect the rest of the sought for informations from the DAO's office, Nalbari.**

With the above directions, the 2nd appeal dated 30.01.2021 is disposed of.
