<u>O R D E F</u> 17.01.2022

The appellant is absent.

Dr. Munindra Sarma, Senior Agril. Dev. Officer (PP) and ASPIO, o/o the Dist. Agriculture Office, Nalbari is present and submits written statement vide letter no. DAO(N)/RTI/2020-21/1374 dated 27.12.2021.

Seen the case record. The appellant submitted one petition dated 13.05.2020 under the RTI Act, 2005 before the PIO of DC's office, Nalbari seeking certain informations. The ADC and PIO, o/o the DC, Nalbari, in turn, transferred the said application to the SPIO, o/o the DAO, Nalbari vide letter no. NA-01/2020/RTI/106 dated 29.05.2021 for taking necessary action. The sought for informations was not received by the appellant in due course of time for which he submitted 1<sup>st</sup> appeal dated 03.12.2020 before the 1<sup>st</sup> appellate authority of o/o the DAO, Nalbari. Still he did not receive the desired informations and submitted 2<sup>nd</sup> appeal dated 30.01.2021 before the Commission.

Seen the letter of the DAO, Nalbari. It is submitted that part of the informations had already been furnished to the appellant vide letter no. DAO(N)/RTI/2020-21/1044 dated 21.08.2021 and he was requested to collect rest of the informations from his office but he did not turn up to collect the same.

It is seen that part of the informations had already been furnished to the appellant and he was requested to collect the rest of the informations as it is voluminous and can't be sent by post. Therefore, the Commission directs the appellant to collect the rest of the informations from the o/o the DAO, Nalbari.

With the above directions, the  $2^{nd}$  appeal dated 30.01.2021 is disposed of.
